Right To Life New Zealand Inc

More than half of the unborn children in New Zealand with Down syndrome are killed before they are born. This is a violation of their human rights and a crime against humanity.

The Down syndrome community are the most persecuted community in New Zealand. In 2017 there were only 47 children born with D S it is estimated that there were 56 babies with DS who were killed before birth. Between 2009 and 2017 it is estimated that 694 children with DS have been killed before birth.



Right to Life believes that this is state sponsored and funded genocide disguised as health care against a clearly defined group within our community.

Can the Prime Minister, Jacinda Ardern, be trusted? In 2017 she made a promise to the disability community in response to concerns expressed by the Saving Down's advocacy group that the new abortion bill would remove the current 20-week prohibition and allow abortions up to birth for foetal abnormality. The Prime Minister responded,

"They have said till 40 weeks, which is wrong, which is wrong. We have time periods already set out in law; I am not proposing changes to that. I am proposing it comes out of the Crimes Act."

Right to Life asks the Prime Minister why she has directed that the Abortion Legislation Bill allow for the killing up to birth of children before birth who may have a disability including Down syndrome [DS]. The current abortion legislation under the Crimes Act allows for the killing of a child before birth "where there is a substantial risk that the child, if born, would be so physically or mentally subnormal as to be seriously handicapped."

DS is considered a mild to moderate disability and Right to Life therefore protests at the killing of any of these special children who are gift to the community.

Screening for DS and other disabilities is offered to all pregnant women in New Zealand. Right to Life believes that this screening is a search and destroy mission that promotes the belief that only the perfect have a right to life.

Those women who's screening reveals a high risk of a baby with DS are encouraged to terminate the life of their child, this would contribute to the average annual abortion rate of 62% for DS.

The Abortion Legislation Bill driven by the Prime Minister holds that abortion does not kill an unborn child and that the child has no rights until it is born. The Prime Minister would therefore logically believe that a child with DS is not a human being and has no right to life.

Right to Life asks then, is it your objective to encourage the elimination of children with Down syndrome through their extermination up to birth? Why are the Churches and the media silent? This election is a sad day for our parliamentary democracy, as the Labour government now has an overwhelming majority that will allow it to legislate as it wishes. Will the news media serve our community by being an effective watchdog?

of Persons with Disabilities.

The Committee on the Rights of Persons with Disabilities of the United Nations officially stated that abortion of children "explicitly" because of a disability violates the Convention on the Rights of Persons with Disabilities, [CRPD]. (Art, 4,5,8)" The Committee is opposed to the imposition of eugenic abortion, which claims that only the perfect have a right to life.

The Minister claims that not including the 20 week restriction of the killing of the unborn diagnosed with a disability in the Abortion Legislation Act 2020 is consistent with New Zealand's obligations under the CRPD. Right to Life challenges this claim. The Act does not explicitly mention fetal abnormality or any other grounds, however, sadly fetal abnormality is widely accepted as grounds for an abortion by his government.
